MANNVSPEST provides pest management service for this property for one or more of the following: Ants, Spiders, Wasps, Fleas, Mites, Mice, Bees, Crickets, Sowbugs, Snails, Ticks, Bedbugs, Rats, Birds, Earwigs, Pillbugs, Flies, Springtails, Mosquitoes, Squirrels, Gophers, Roaches, Centipedes, Moths, Beetles, Scorpion, Silverfish, Millipedes, Gnats, Louse, Grasshoppers, Termite, and other insects and vermin that might appear and attack you and/or your property.

CAUTION: PESTICIDES ARE TOXIC CHEMICALS

State law requires that you be given the following information:

“CAUTION-- PESTICIDES ARE TOXIC CHEMICALS. Structural Pest Control Companies are registered and regulated by the Structural Pest Control Board, and apply pesticides which are registered and approved for use by the California Department of Pesticide Regulation and the United States Environmental Protection Agency. Registration is granted when the state finds that, based on existing scientific evidence, there are no appreciable risks if proper use conditions are followed or that the risk are outweighed by the benefits. The degree of risks depends upon the degree of exposure, so exposure should be minimized.”
