

HOMEOWNER'S PREPARATION PRIOR TO TREATMENT

1. Take all beds completely apart (Framing, box spring, legs, etc.). Put mattress and box spring up against the wall.

**ALL PLASTIC AND/OR BED COVERS MUST BE REMOVED
FROM MATTRESS AND BOX SPRINGS PRIOR TO TREATMENT**

***** DO NOT PLACE ANYTHING ON BED OR FURNITURE *****

2. All clothing, linens and bedding **MUST BE WASHED & DRIED (high heat) or dry cleaned prior to treatment then sealed in plastic bags and set ON "NON-CARPET AREA" (bathroom/kitchen/patio).**
3. Remove all wall hangings from the walls. Pictures must be removed from frames and placed against the wall for treatment.
4. Remove all dresser drawers and completely empty them out. All clothing that were removed from the drawers **MUST BE WASHED & DRIED (high heat) and sealed in plastic bags and set ON "NON-CARPET AREA" (bathroom/kitchen/patio).**
5. Aquariums to be sealed off with plastic half way down the tank. Filter to be unplugged for a mandatory four (4) hour period.
6. Suitcases & backpacks **MUST BE EMPTIED OUT AND LEFT IN UNIT.**
7. All closets must be completely emptied out.
8. Floors and carpet must be free of debris. Carpet areas, sofas, chairs, etc. must be vacuumed thoroughly. Throw away vacuum bag and replace with new one.
9. All electrical items must be unplugged.
10. All windows must be closed and fans turned off at the time of the treatment.
11. Pull carpet from baseboards (carpet needs to be sprayed underneath) ****Note: may be done by maintenance depending on your situation. (May or may not be required – your technician will advise you)**
12. No other "store bought" pest control products may be used after MANNvsPEST treatment.
13. All persons and pets may re-enter the premises four (4) hours after time posted on the door tag.
NOTE: persons with PREGNANCY, AILING HEALTH, OR INFANTS UNDER ONE (1) YEAR OLD should consult a physician prior to service. In the event you are unable to contact a physician MANNvsPEST recommends a minimum of twenty four (24) hours before re-entering.

NOTE: STATE LAW PROHIBITS SPRAYING WHEN AREAS LISTED ARE NOT PROPERLY PREPARED. IN ORDER FOR YOUR TREATMENT TO BE EFFECTIVE THESE PROCEDURES MUST BE FOLLOWED COMPLETELY.

HOMEOWNER'S FOLLOW-UP

1. Upon returning to the premises, open all windows to air out residence.
2. Remove plastic from aquariums and plug filter back in.
3. **DO NOT USE LIQUID CLEANSER OR WATER TO CLEAN** after the treatment as this will wash away residue barriers in treated areas. However, kitchen and bathroom counter tops may be cleaned.
